1. **SPONSOR:** The Sponsor set out in the Contest Summary is the sole sponsor of the Contest at the Center on the Contest Date.
2. **ELIGIBILITY: NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED BY LAW.** The following are not eligible to participate in the Contest, if during the Contest Entry Period, they were: (i) Sponsor, its parent companies, affiliates, subsidiaries, advertising or promotional agencies; or (ii) respective officers, directors, employees and agents of the parties listed in (i); or (iii) members of the immediate family of, and people living in the same household with any individual listed at (i) and (ii). ## **EXHIBIT A**

### **COSTUME CRITERIA, PROCEDURES AND SELECTION**

Participants who wish to enter their dog into the Costume Contest may do so by completing the entry form at the Doggy Costume Contest registration table and allowing the contest administrator to take a photo of the dog wearing their costume. A costume may consist of any accessories or articles of clothing worn by the dog.

Costumes will be judged based on the following criteria and will be scored on a scale from 1 to 10 for each.

Creativity and Originality  
Attention to Detail  
Overall Presentation  
Humor

The highest overall score will be awarded with "Best Costume". In the event of a tie, the winner will be randomly drawn from the highest scoring entries.

The highest score in Creativity and Originality will be awarded with "Most Original Costume". In the event of a tie, the highest overall score will determine the winner. In the event of a tie after the overall score is factored in, the winner will be randomly drawn from the highest scoring entries.

The highest score in Humor will be awarded with "Most Original Costume". In the event of a tie, the highest overall score will determine the winner. In the event of a tie after the overall score is factored in, the winner will be randomly drawn from the highest scoring entries.
